### POSITION MINIMUM QUALIFICATIONS

- Must hold a degree in elementary, early childhood, or environmental education or have 3 months full-time or equivalent (460 hours) verifiable experience working with children. (Applicants that do not hold an applicable degree, must submit letters of experience verification)
- Ability to hike moderate to difficult trails
- Certification in First Aid/CPR or ability to obtain certification before camp (A class will be offered)
- Must be at least 18 years of age, due to childcare licensing requirements
- Available to work the entire 5 weeks of employment

### PREFERRED QUALIFICATIONS

- Strong background in natural sciences, environmental education
- Some knowledge of outdoor safety skills and Leave No Trace techniques

### ESSENTIAL JOB DUTIES

- Ensure the safety of up to 15 campers, while hiking, leading experiential learning activities and nature encounters
- Check-in and out campers daily following Colorado State Day Care Licensing requirements
- Prepare each day's activities following curriculum and philosophy of the program
- Organize and care for equipment
